#### BACKGROUND

The Ecuadorian Foundation for the Research and Development of Botany "FUNBOTANICA", is a non lucrative NGO, legally established in 1991 which main purpose is to promote and diffuse the botanical research in Ecuador. Currently, located in Loja, where it works with the Reinaldo Espinosa Herbarium at Loja's National University. FUNBOTANICA organized the three former Ecuadorian botanical meetings.

The abstract must include the study goals, main results and conclusions, do not include bibliographical references. Please add **five** key words not included in the title.

The text must be clear and in third person.

The due date for the abstracts reception is **May 30, 2003**. Only two presentations per author will be accepted.

Abstracts may be presented in Spanish or English under the following format:

- 1. Configure the page in A4 format.
- 2. Use WORD format for Windows or RTF, using Arial12 points and double space.
- 3. 2.5 cm margins on each side.
- 4. Title in bold and center and **no** subtitles.
- 5. The author name in the left margin in bold type.
- 6. Under the name, the e-mail, address and institution
- 7. Scientific names should be written in italics.
- 8. Abstracts exceeding **250** words will not be accepted.

#### **POSTER'S FORMAT**

Posters could be presented in Spanish or English with the following format:

- 1. The poster's size can not exceed 90 x 120 cm.
- 2. The title should be centered and in upper case letters.
- 3. Authors' names should be located at the left margin or centered in lower case letters..
- 4. Under the name, the e-mail, address and institution.
- 5. Scientific names should be written in italics
- 6. The poster's text should focus the study goal, introduction, methods, results, and the main conclusions and could include relevant bibliographical references.
- 7. The posters will be evaluated by a scientific committee for each area and the winners will receive a prize at the end of the meeting.

## **GUIDELINES FOR PAPERS' SUBMISSION**

The participants in the meetings are invited to submit their manuscripts in either Spanish or English. In order to speed up the editing process and publishing, authors most follow these guidelines. Manuscripts that not follow the guidelines will be rejected or return to the authors for correction before any decision is taken as to their acceptance for publication.

#### Submission

- 1. Manuscripts must be submitted in triplicate one original and two copies no later than August 30, 2003.
- Manuscripts should be submitted to one of the following: M.Sc. Pablo Lozano, FUNBOTANICA Ing. Hernán Lucero, Universidad Técnica Particular de Loja Dipl.Blgo. Stefano Torracchi, Universidad Técnica Particular de Loja

## **Technical requirements**

- 3. Use A4 paper (or 8,5" x 11") and write only on one side of the paper.
- 4. All text, including figure captions, table headings, tables, etc., should be double space.
- 5. Use a laser printer to make a clear text.
- 6. Leave at least 2,5 cm margins on all sides.
- 7. Number all pages in the upper right-hand corner including title page, text, tables, figure captions, etc. Put the name of the author or first author before the page number: "Fulano p. 1" or "Arias *et al.* P. 1".
- 8. Submit all illustrations mounted on carton preferably the same size of manuscript paper (A4 o 8,5" x 11"). The illustrations should be number consecutively. On the back side of each illustration the name of the author, entitle of paper should be indicated. Each of the three copies of the manuscript submitted should be accompanied with photocopies of the illustrations, numbered in the front side.

## Disks

- 9. If possible manuscript should be accompanied with an electronic version of it. Preferably in WINDSOWS WORD
- 10. The disk should be labeled with: a) author's name, b) date the manuscript was copied onto the disk, c) the manuscript title, d) the software used (incl. version), and e) the operating system used Ex.: "Microsoft Word in Macintosh".
- 12. If submitting an electronic version this must be an accurate copy of the manuscript, and not a former or new version.
- 13. When presenting an electronic version you should not attempt to design the text. Use 12 points letters all throughout the text, avoid using bolds, italics and whole words in upper cases in both the title and the text. Do not justify the right margin. The only formatting requested is that Latin names of organisms and titles of works included in the Literature Cited section should be <u>underlined</u>.
- 14. Use only one (1) space after periods, colons and question marks.
- 15. Use "enter" only at the end of paragraphs, titles, headings, etc. Let the word processing program break the lines in other places.
- 16. Use a tab stop to indent each new paragraph. Do not indent the first paragraph after a heading or subheading.
- 17. Do not center headings or subheadings: let them stay flush left.
- 18. Tables should be created in the same program used for the text, but they must be stored on a separate file on the disk. Use tab stops, not space, for creating columns. Remember that the final size of the printed pages will be 11 X 15 cm, so your tables should be designed to fit into that space in the final typesetting.

#### Parts of the manuscript

- 19. The manuscript should not exceed **5.000** words. It should include some or all of the following elements:
  - Title page Resumen Abstract Introduction Materials & Methods (incl. Study area) Results Discussion Acknowledgements Literature Cited Figure Captions Table headings

Each of these should start a new page in the manuscript.

- 20. The **Title page** should include the following information: a) the title of the paper, b) The full name of the author(s), c) Current author(s) address including phone, fax and e-mail, and d) If there is more than one author, indicate to whom the correspondence should be sent.
- 21. The **Resumen and Abstract** should be respectively in Spanish and English in all manuscripts. The Resumen and Abstract should consist of a single paragraph, short and concise (no more than 250 words) and summarize the results of the paper. They should be **informative** and not **indicative**, for instance say " In *Ecuador all species of Juncaceae grow between 1000 and 4500 meters altitude, most of them above 2500 meters*" which is **informative**. Do not say "*The altitudinal limits of Ecuadorian species of Juncaceae are discussed and their limits are given*" which is **indicative**.
- 22. The Introduction, Materials & Methods, Results and Discussion sections of the papers may in some cases be better divided differently. If the paper describes a study carried out in a particular area, this should be described in a subheading under Materials & Methods. Results and Discussion may in some cases be combined.
- 23. Collect all acknowledgements under a single paragraph and keep them short.
- 24. The **Literature Cited** section should include all publications referred to in the text. It should not include unpublished reports or other sorts of unavailable information. Thesis should be cited only when available in a library. In the text references should follow the "name-and-date system", for instance: Laegaard (1992); Olesen & Balslev (1990); Van der Maarel *et al.* (1987); Whitmore (1984). Two or more references cited in the same place in the text should be arranged first alphabetically and then chronologically.
- 25. In the Literature Cited section, the titles and journals names must be underlined and will appear in bold in the final edition. References with two or ore author should be arranged first alphabetically and then chronologically. The names of cited journals should be given in full.

- 26. The sections **Figure Captions** and **Table headings** should both start on a new page. Number the figures consecutively with Arabic numerals (1,2,3...) in the order they should appear in the text. Number consecutively the tables with roman numbers (I,II,III,IV,...) in the order they should appear in the text. When writing figure captions and table headings, make sure each is understandable without reference to the text.

#### **Preparation of Figures**

26. Figures may consist of line drawings, maps, or half tone black and white photographs.

- 27. All figures should be mounted on carton, preferably on the same size as the manuscript paper (A4 o 8,5" x 11").
- 28. Do not combine photographs and line drawings in the same figure.
- 29. Design figures so they will eventually fit the final size of the book (11 x 15 cm). Make sure that the lettering or details have proper size so they will not be illegible when reduced to that size (numbers, letters, and symbols should be at least 1.5 mm high after the illustrations have been reduced to fit the printed page). Ideally, illustrations should be prepared at one and a quarter size of the final publication size, for instance: 13,75 x 18,75 cm to be reduced into 11 x 15 cm.
- 30. Different elements in the same figure should be lettered a, b, c, d, etc.
- 31. Photographs should be printed in satin high contrast paper.
- 32. Lineal drawings and maps should be prepared with black ink or in a high density laser printer .
- 33. Text in figures and maps should use easily readable lettering, for instance Arial.
- 34. If figures have been previously used, is the author's responsibility to obtain permission from the copyright owner if applicable.

#### Editorial procedures

- 35. When the manuscript has been received by the editors it will be sent out for review by at least three experts in the theme covered in the paper. The reviewers will be asked to comment on the quality of the content of the paper as well as its presentation and adherence to the guidelines. This part of the editorial process may take several months.
- 36. When the editors have the comments from the reviewers they will decide whether the paper is acceptable for publication in the proceedings volume.
- 37. If the paper is not acceptable it will be returned to the author.
- 38. If the paper is acceptable for publication the editors will combine the comments of the three reviewers with their own editorial comments and will return the manuscript to the author. The author must then make the changes. Usually the time given for corrections is no more than a month.
- 39. When the corrected paper is returned to the editors they will copy-edit and send it to the printer.
- 40. After the manuscript has been formatted for publication a print out ("page proofs") will be sent to the author for correction of errors and approval. At this point it will not be possible to make changes to the manuscript, but only to correct errors. The author should return the page proof to the editors within a week or so.
- 41. The printer will make the needed corrections to the manuscript. If necessary a second page proof may be sent to the author at this point, but usually this will not be the case.
- 42. The editors will combine all the manuscripts to the final volume of the proceedings of the meetings.

#### **Final remarks**

- 43. The speed of publication of a symposium depends on the quality of the collaboration between the authors of the manuscripts, the reviewers, the printer and the editors. Each time one of these collaborators take longer than needed to answer to the request, the entire process will be slowed down..
- 44. We hope to publish the proceedings within two years of the meeting, but it depends on having the manuscripts on time and on the prompt response of the authors, reviewers and printers along the editing process.
